

6. If an exchange student has undertaken research, then the host institution will evaluate the exchange student's performance in the research, and issue a letter to that effect, together with a technical "report" of the research carried out.



7. Both the institutions agree to provide suitable accommodation and living expenses for student exchange in accordance with the rules and regulations governing these institutions.
8. To avail travel expenses, the students can apply for existing funding programs at their respective home institutions.
9. The exchange students will pay tuition and other fees at their home institution.
