The Principal directed all the convenors to apply for sanction of fund will in time and complete all codal formalities.

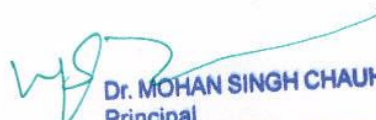
